Ngyuddadunmardi Ariki Tribal Court was called and held on Friday the 6th September by the True Crown, Lady Crown Turikatuku III, Lord Crown Kooradamandarngee, Crown Assembled Owners and Assembled Crown Guardians of Rangihou & Baludarri Lands.

Ngyuddadunmardi Ariki Tribal Court Hearing was called due to the fact that on the 21st August 2019 in the Federal Court of Australia

- (a) Judge Jacqueline Gleeson adjourned the court matter with '**no future date**'.
- (b) Lady Crown Turikatuku III sent a Letter Rogatory to the Judge and instructed her of a date being the 18th September 2019. To date the '**Judge has not responded**.'
- (c) Judge Jacqueline Gleeson stated on the court record page 13, that her '**powers are limited**'.
- (d) Lady Crown Turikatuku III stated on the court record page 19, that he will '**invoke tribal law**'
- (e) Lady Crown Turikatuku III stated on the court record page 19, that he has already '**invoked God's law**'

Ngyuddadunmardi Ariki Tribal Court Hearing was initiated with the Divine Rights & Authority of:

- (a) God's Law's (Laws of the Land); and
- (b) First Loes in Time, First in Line, Best in Law; and
- (c) Grandmother Skin Loes; and
- (d) International Protectorate, Laws on the Sea - United Tribes Flag 1835; and
- (e) Queens Letter to Maori 1858; and
- (f) Sovereign Nations Treaty for the Protection of Rangihou and Baludarri Sacred Burial Sites and Lands; and
- (g) Letters Patent 1st July 2019 – The Kingdom of God on Earth & Governance of Love & Guardians of Divinity & The Royal Charter; and
- (h) Letters Patent 8th August 2016 – Paremata Rangihou Sovereign Nation & Embassy & Governance of Love & Guardians of Divinity & The Royal Charter; and
- (i) He Whakaputanga o te Rangatiratanga o Nui Tireni 1835; and
- (j) Te Tiriti o Waitangi 1840; and
- (k) 23 Unrebutted Affidavits filed on the Federal Court of Australia record, that stand in Law; and
- (l) Common Law.

Statement of Facts that were discussed were:

1. Parramatta City Council, the defendant, the wrongdoer;
 - (a) Has no Rebuttal to 7 Years of numerous notices, invoices, commercial liens and statutory demands.
 - (b) Has no Rebuttal in the Federal Court hearing on the 21st August 2019.
 - (c) Arrogantly switched identities in the courtroom to 'City of Parramatta' in a blatant attempt to say that they are not a company, but a body politic. Fraud, Perjury and Misprison of Treason was committed in the Court in the Presence of Judge Jacqueline Gleeson supported by the Court Manuscript.
 - (d) Lied and got caught red handed by the Judge Jacqueline Gleeson pointing to The Local Government City of Parramatta and Cumberland Proclamation 2016 that was created for the entity 'City of Parramatta'
 - (e) Has no Proclamation 2016 to stand on the court as it is irrelevant to the matter and not the Parramatta City Council
 - (f) Has no Local Government Act 1993 to stand on as Local Government is not recognized in the constitution
 - (g) Has no rebuttal to 7 years of notices and 23 Affidavits on the Federal Court of Australia Record. Today all documentation and facts stand in law.
 - (h) Is a De son tort Trustee – Lady Crown instructed Judge Gleeson to sack the De Son tort Trustee, however she did not do it.
 - (i) Will have charges laid against them for Misprison of Treason.
 - (j) Were arrogant, fraudulent, were perverting the course of justice, were obstructing the course of justice, failed in their fiduciary duties, Professional Misconduct and ignorantly performed with a Lack of Candour.
 - (k) Was systematically dishonest on eleven accounts. He intentionally entered into a course of conduct which involved deliberate deception and dishonesty in an attempt to deceive You the Judge and us being the Creditor.

2. Mr Alexander White, the solicitor swore an Oath of Office - *"I, Alexander White do swear [or solemnly, sincerely and truly declare and affirm] that if I am enrolled as a lawyer by the Supreme Court of New South Wales I will truly and honestly conduct myself in the practice of a lawyer of the Supreme Court of New South Wales and I shall faithfully serve as such in the administration of the laws and the usages of that State according to the best of my knowledge, skill and ability."*

3. Mr Alexander White, the solicitor the defendant is required by law to be faithful to the oath of office, the courts, fellow practitioners and clients and as such, considerable trust is placed in him to perform with the upmost of professionalism and integrity. The conduct of the defendant has demonstrated aspects of his character that are “fundamentally inimical to fitness to practice as a legal practitioner”. The defendant is not a fit and proper person to discharge the responsibilities of practising as a legal practitioner. Alexander White will charges laid against him for Misprison of Treason.

4. The Defendant acted with a Lack of Candour as recorded in the Court Manuscript as follows:

1.1. Perverting the course of justice- responding as City of Parramatta

MR WHITE: Well, your Honour, the application for winding up is under part 5.4 of the Corporations Act, and that part 5.4 is only applicable in respect of companies, of which the City of Parramatta is not one.

1.2. Obstructing the course of justice- responding as City of Parramatta

MR WHITE: In the present circumstances, the defendant is not registered under the Corporations Act, but was rather constituted by the Local Government Act New South Wales and the Local Government (City of Parramatta and Cumberland) Proclamation (2016).

1.3. Perverting the course of justice- responding as City of Parramatta

MR WHITE: A council is a body politic of the state with perpetual succession and legal capacity and powers of an individual, both in and outside the state.

1.4. Obstructing the course of justice- responding as City of Parramatta

MR WHITE: The council is not a body corporate (including a corporation).

1.5. Obstructing the course of justice- responding as City of Parramatta

HER HONOUR: Okay. So my question to Mr White is how do I know that the Parramatta City Council identified in that way is a council within the meaning of section 220.

MR WHITE: So, your Honour, what the Local Government (City of Parramatta and Cumberland) Proclamation 2016 - - -

1.6. Perverting the course of justice- responding as City of Parramatta

MR WHITE: It's the Local Government (City of Parramatta and Cumberland) Proclamation 2016. HER HONOUR: Yes. LADY CROWN: Your Honour, if I may speak, where's the Parramatta City Council? Disappeared.

1.7. No Rebuttal to the ABN status in the affidavits so it stands in law

MR WHITE: And, of course, as your Honour would be aware, the – one does not need to be a company or a corporation to hold an ABN; it is merely a utility for GST purposes.

1.8. Perverting the course of justice- responding as City of Parramatta

HER HONOUR: Are you able to show me something in this proclamation which indicates that the entity you're talking about is the successor of Parramatta City Council, for example?

MR WHITE: Well, what I can take your Honour to is, if you have the proclamation available, schedule 1 refers to the new council.

1.9. Perverting the course of justice- responding as City of Parramatta

MR WHITE: Schedule 1 is titled Provision for the City of Parramatta. New council means City of Parramatta Council.

1.10. Perverting the course of justice- responding as City of Parramatta

MR WHITE: Areas amalgamated – apologies, your Honour – City of Auburn, City of Holroyd, City of Parramatta.

1.11. Perverting the course of justice- responding as City of Parramatta

MR WHITE: So, your Honour, my submission is that in circumstances where the plaintiff has referred to the Parramatta City Council, the true entity is in fact the City of Parramatta and that - - -

1.12. Perverting the course of justice- responding as City of Parramatta

MR WHITE: Insofar that the plaintiff has made a mistake in relation to the defendant's trading name.

5. Ngyuddadunmardi Ariki Tribal Court resolution, by the evidence tabled is that the **defendant is standing naked with No Local Government Act 1993; No Proclamation 2019; No Constitution 1900** as it clearly states that Local Government is Not Recognized (supported by Attorney General letter dated 8th June 2011); and **No Rebuttal to Lady Crown's 23 Affidavits and Asseveration**. Therefore it is a **Constitutional Issue, Treaty Issue and Judicial Issue of International proportion**. In the court room Lady Crown invoked God's Laws and Tribal Laws, hence the meeting today.

RESOLUTION

6. Ngyuddadunmardi Ariki Tribal Court voted in favor of Tribal Law being invoked and Corporations Law 459G that the Parramatta City Council ABN 49 907 174 773 including all derivatives of, associated entities, business names, trading names are to be wound up and liquidated effective immediately, pursuant to the Originating Application Sections a, b, c, d, e, f, g & h.
7. Ngyuddadunmardi Ariki Tribal Court voted in favor of reducing the Statutory Demand dated 1st April 2019 to Two Hundred and Eight Million to be paid from the Public Trust and Parramatta City Council to Lady Crown, the Paramount Arikiniui of Paremata, of the Office of the Crown within thirty days: Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599.
8. Ngyuddadunmardi Ariki Tribal Court voted in favor of instructing that all profits made from Rangihou & Baludarri Lands since 8th May 2019 to be deposited in the Office of the Crown, Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599 effective immediately, overnight.
9. Ngyuddadunmardi Ariki Tribal Court voted in favor of occupying Sacred Rangihou & Baludarri Lands effective immediately, Land that in the hands of the Parramatta City Council and the State Government, is illegitimate property that was acquired by force and injury to others, therefore genocide & crimes against humanity was enacted. Lands, Crown Lands and buildings being;
 - a. Rangihou Lands being 112 Acres - From Parramatta River, up Morton Street, left onto Victoria Road, left onto Wilde Avenue and back to the Parramatta River boundaries; and
 - b. Baludarri Lands from the Parramatta River, up Morton Street, right onto Thomas Street, right onto James Ruse Drive back to the Parramatta River boundaries; and

- c. Rangihou Crown Land - James Ruse Reserve, 109 Harris St, 115 Harris St, 137,143,145,147 George Street, The Waterways Between Rangihou Reserve And Queens Wharf Reserve, Queens Wharf Reserve, Robin Thomas Reserve; and
 - d. 116 Macquarie Street - Corner of Charles St and Macquarie St; and
 - e. Deakin Park in Silverwater - Corner of Beaconsfield St and Silverwater Road; and
 - f. Callan Park in Rozelle - Parramatta River, up Wharf Road, Military Road, Central Ave, Waterfront Drive To Parramatta River - Including Mauri Ratana Rock Carvings On The Rocks; and
 - g. Rodd Island.
10. Ngyuddadunmardi Ariki Tribal Court voted in favor of instructing that the Parramatta City Council to make a Public Announcement to Channel 9 Media within 24hrs of these orders being served, that they have been relieved of their fiduciary duties as Trustees and as the Local Parramatta City Council authority. That the Office of the Crown, with Royal Prerogative Authority, God's Law's and the First Laws in Time, will be the upstanding Administrators. That Lady Crown, the True Crown will be the Paramount Arikiniui of Paremata Rangihou Sovereign Nation & Embassy.

BILL OF COSTS

11. Ngyuddadunmardi Ariki Tribal Court voted in favor of instructing that the Outstanding Bill of costs as stated on affidavit dated 9th July 2019 to be paid effective immediately by Mr Alexander White and/or Defendant and/or Sparke Helmore Lawyers. Deposited into the Office of the Crown, Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599 effective immediately, overnight.
12. Ngyuddadunmardi Ariki Tribal Court voted in favor of instructing that the Outstanding Invoice as stated in Asseveration dated 30th August 2019 to be paid effective immediately by Mr Alexander White and/or Defendant and/or Sparke Helmore Lawyers. Deposited into the Office of the Crown, Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599 effective immediately, overnight.
13. Ngyuddadunmardi Ariki Tribal Court voted in favor of instructing that any Bill of Costs presented by the Defendant, be dismissed effective immediately.

CHARGES

14. Ngyuddadunmardi Ariki Tribal Court voted in favor of Tribal Law being invoked and 78B Judiciary Act 1903 on the 21st August 2019 the Parramatta City Council committed a serious constitutional breach against the Commonwealth of Australia Constitution Act 1900 [9th July 1900] Section 51 by acting in the capacity of Local government with no head of power, where no local government exists or is recognised. By such enactment, an offense of Misprision of Treason was created by the overt Act of Treason titled the Local Government Act 1993 and the Local Government (City of Parramatta & Cumberland) Proclamation 2016. Charges and Fine to be imposed.

15. Ngyuddadunmardi Ariki Tribal Court voted in favor of Tribal Law being invoked and Crimes Act 1900 pt 2, sect 11,12 & 16, Crimes Act 1914-1973 Section 24F, Crimes Act 1914 Sect 42, Crimes Act 1958 - Sect 9A, Crimes Act Sec 80 1.AA on the 21st August 2019 The defendant did intentionally and perversely masquerade as a different corporate entity, pointing to an invalid and illegal corporation City of Parramatta and the Local government (City of Parramatta & Cumberland) Proclamation 2016. The defendant did intentionally conspire with other principals to obstruct, prevent, pervert and defeat the course of justice in relation to judicial power of the court, against King George the third's Sovereign Lady Crown, an Ambassador of the Lord Jesus Christ, against the people of the commonwealth and against the Originee Sovereigns of these lands. By such enactment, the defendant did in fact commit an overt act of Perjury and Misprision of Treason. Office of the Crown herein brings charges against the defendant, being the Chief Executive Officer with Perjury and Misprision of Treason under the abovementioned acts. Charges and Fine to be imposed.

16. Ngyuddadunmardi Ariki Tribal Court voted in favor of Tribal Law being invoked and Crimes Act 1900 pt 2, sect 11,12 & 16, Crimes Act 1914-1973 Section 24F, Crimes Act 1914 Sect 42, Crimes Act 1958 - Sect 9A, Crimes Act Sec 80 1.AA on the 21st August 2019 Mr Alexander White (Solicitor) for Parramatta City Council did intentionally and perversely masquerade as a different corporate entity being the City of Parramatta, pointing to an invalid and illegal Local government (City of Parramatta & Cumberland) Proclamation 2016. The defendant did intentionally conspire with other principals to obstruct, prevent, pervert and defeat the course of justice in relation to judicial power of the court, King George the third's Sovereign Lady Crown, against the people of

the commonwealth and against the Originee Sovereigns of these lands. By such enactment, an overt act of Perjury and Misprision of Treason was committed. Office of the Crown herein brings charges against Mr Alexander White with Perjury and Misprision of Treason under the abovementioned acts. Charges and Fine to be imposed.

ANY OUTSTANDING ISSUES

17. Ngyuddadunmardi Ariki Tribal Court voted in favor of removing all outstanding issues, Interlocutory orders and bills of cost from the list of cases awaiting finalisation in the Federal Court of Australia.
18. Ngyuddadunmardi Ariki Tribal Court voted in favor of instructing that no amendment be made to the Originating Process to reflect any other entities.
19. Ngyuddadunmardi Ariki Tribal Court voted in favor of instructing that any future breaches against the Creditor will invoke Tribal Law, the Claim of Right, Terms & Conditions, Fee Schedule, Copyright Agreement, Trademark User Agreement and Crimes Act 1900, 1914 & 1958.

AUTHORITY

20. Ngyuddadunmardi Ariki Tribal Court voted in favor of The Office of the Crown's authority to Act comes from God under the protection of the Kingdom of God on Earth &
 - a. God's Law's (Laws of the Land); and
 - b. First Loes in Time; and
 - c. Grandmother Skin Loes; and
 - d. International Protectorate, Laws on the Sea - United Tribes Flag 1835; and
 - e. Queen's Letter to Maori 1858; and
 - f. Sovereign Nations Treaty for the Protection of Rangihou and Baludarri Sacred Burial Sites and Lands; and
 - g. Letters Patent 8th August 2016 – Paremata Rangihou Sovereign Nation & Embassy & Governance of Love & Guardians of Divinity & The Royal Charter; and
 - h. Letters Patent 1st July 2019 – Kingdom of God on Earth & Governance of Love & Guardians of Divinity & The Royal Charter; and; and
 - i. He Whakaputanga o te Rangatiratanga o Nui Tireni 1835; and

- j. Te Tiriti o Waitangi 1840.
21. Ngyuddadunmardi Ariki Tribal Court agreed that leave be granted for the defendant/wrongdoer to seek intervention and or remedy in the International Court of Justice and the United Nations Human Rights Commission, if they deem necessary.
 22. Ngyuddadunmardi Ariki Tribal Court support and uphold of the Tribal Adoption Treaty, Ambassador for the Originee Sovereigns of Lady Crown Turikatuku III via Treaty to Ghungalu, Bidjara, Kullilli, Biria, Manandangie, Kungari and Githabul Ngarakbul dated 1st January 2019.
 23. Ngyuddadunmardi Ariki Tribal Court Hearing was a unanimous vote for Final Orders dated 6th September 2019 to be filed on the Federal Court Record with instructions.
 24. Ngyuddadunmardi Ariki Tribal Court agreed that no valid rebuttal exists therefore invoke the Final Orders which now stand in law, un rebutted, accepted by equitable estoppel by acquiescence.
 25. Ngyuddadunmardi Ariki Tribal Court agreed to instruct a Sheriff, the Police and a Liquidator will be appointed to enforce the Final Orders.
 26. Ngyuddadunmardi Ariki Tribal Court agreed to instruct full disclosure of Parramatta Chief Executive Offices, Managing Directors, 9.7.2019 List and Mr Alexander White - Full Name (Birth Certificate), Current Residing Address, Date of Birth, Tax file Number Documents to be emailed to participant999@protonmail.com.
 27. Ngyuddadunmardi Ariki Tribal Court agreed to instruct full disclosure of Trusts, Deeds, Stocks, Property Portfolio, Insurance Policy & Underwriters Documents to be emailed to participant999@protonmail.com.
 28. Ngyuddadunmardi Ariki Tribal Court agreed to instruct that a full tax audit be undertaken immediately.
 29. Ngyuddadunmardi Ariki Tribal Court agreed to instruct that a copy of the Court minutes from 6th September 2019 be attached to the Final Orders.

30. Ngyuddadunmardi Ariki Tribal Court agreed to file on the court record the Tribal Adoption Treaties for Judge Lady Crown Turikatuku III, Judge Lord Crown Kooradamandarnee and Judge Arikini Kawenata and the Registrar Appointment for Lady Waiporoporo.

31. Tabled at the meeting was copies of

- a. the Manuscript from the Court Hearing 21st August 2019.
- b. the Australian Constitution 1900 which states New Zealand is a state of Australia
- c. Sovereign Nations Treaty for the Protection of Rangihou and Baludarri Sacred Burial Sites and Lands; and
- d. Letters Patent 8th August 2016– Paremata Rangihou Sovereign Nation & Embassy & Governance of Love & Guardians of Divinity & The Royal Charter; and
- e. Letters Patent 1st July 2019 – The Kingdom of God on Earth & Governance of Love & Guardians of Divinity & The Royal Charter; and
- f. Queen’s Letter to Maori; and
- g. Grandmother Skin Lores; and
- h. Tribal Adoption Treaties; and
- i. Registrar Appointment Certificate; and
- j. Judge Appointment Certificates.

32. Motion was passed to add the front cover (or the document) of the above tabled protectorates and certificates to the minutes and the final orders. Also to lodged on the court record.

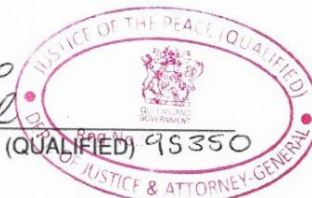
