**Ancient Clan meeting:**

True Common Law Ancient Clan Court Meeting was heard on the 16<sup>th</sup> September 2014 between Defendants Probuild Construction Managers Nick Gaudry, Partner (name unknown) and Security Officer (name unknown) and Plaintiff Turikatuku III Gumada, Court Witnesses. The NSW Parramatta Police were present, presenting as peace officers on behalf of Paremata O Baludarri Rangihou Sovereign Nation & Embassy.

A sacred circle was made on the land, the circle blessed, Karakia undertaken, and then the Probuild Managers were told where to sit in the circle. They were informed that they were in our True Ancient Clan Common Law Court with assembled owners as witnesses alongside our ancestors both Originee and Maori.

## ITEMS DISCUSSED

1. Turikatuku informed all assembled court witnesses that she and Charlotte Howell presented at 2 Morton Street development site, after being alerted by ancestors of a desecration on the Rangihou and Baludarri Lands on the previous day. On presenting Turikatuku III Gumada yelled to the excavator controller to stop digging *“that the area that he is digging is where our children are buried, to stop immediately”*. He stopped immediately and called Head Office. Turikatuku III Gumada proceeded to the main office and handed Probuild Construction Manager Nick Gaudry the Notice of International Jurisdiction 8<sup>th</sup> September 2014 over the subject area of land including all Rangihou and Baludarri Lands. A meeting was then called for 16<sup>th</sup> September with Probuild Construction Manager Nick Gaudry, CEO of Starrylands Sydney Pty Ltd and Parramatta City Council CEO Greg Dyer [Nick was responsible for organizing all attendances].
2. Prior to the meeting commencing a call came from Aotearoa for Nick Gaudry from Hoori Harihona Paerata Tribal Elder of Aotearoa and Justice of the Peace. He was told that he and his staff were committing a ‘Hara’ sin against the land, Massacre and Burial Site, the Originee burial within and the ancestors. They were advised to cease and desist from desecrating the land, Massacre Site and Burial Site immediately. Nick was reminded again that Hoori is a Justice of the Peace of Aotearoa. This request was ignored.
3. Probuild Construction Manager Nick Gaudry gave notice of non attendance for **Starrylands Sydney Pty Ltd CEO M. Dibben (no show) and Parramatta City Council CEO Greg Dyer (no show)**.
4. Turikatuku III Gumada announced that she is standing as **Sovereign in Right** and on behalf of the **Paremata O Baludarri Sovereign Nation in Right**, Standing in our **True Ancient Clan Common Law Court** with witness and our ancestors.
5. Turikatuku asked Probuild Construction Mangers Nick Gaudry to share with the witnesses of the True Ancient Clan Common Law Court the discussion that they had on the phone earlier on this day.
6. Probuild Construction Manager Nick Gaudry stated that he is aware that the subject area in the Notice of International Jurisdiction dated 9<sup>th</sup> September 2014 are areas of high sensitivity for Originee and Maori dating back to pre-European days and that the lands are under International Jurisdiction; that he is under a contract with Starrylands Sydney Pty Ltd; that we have to speak with them; that they are going to return and start up the excavators again. The then proceeded to ask if he could do ceremony on the land to fix the problem. He also asked if we would ever build on the land.
7. Turikatuku clearly outlined the significance of the Massacre and burial site and the tapu (curse) over the said lands that were currently being unlawfully desecrated, disrupted, disrespected and violated; **and**
8. Turikatuku III Gumada reminded Probuild Manager that Paremata O Baludarri Rangihou Sovereign Nation & Embassy are under International Jurisdiction, sanctioned by Jingki Sovereign Queen of Gondwana Land to Administer, Protect and Honor the Rangihou and Baludarri Sacred Burial Sites and Ancients Lands, under Mortuary Law and Ancestral Originee Grandmothers Skin Lore; **and**
9. Turikatuku III Gumada reminded Probuild Manager that Paremata O Baludarri Rangihou Sovereign Nation and Assembled Owners are the ancient clan land holders, protectors,

knowledge keeps and guardians of Rangihou Lands, Rangihou Sacred Burial Sites, 1A Morton Street, 2 Morton Street and Baludarri Wetlands, Gondwana Land; **and**

10. Turikatuku III Gumada reminded Probuild Manager that Paremata O Baludarri Rangihou Sovereign Nation & Embassy are under Gods Lore/Law, Common and International Law, Ancestral Originee Grandmother Skin Lore, Treaty, Mortuary Law and Maori (Kawa, Tikanga, Customary) Lore/Law; **and**
11. Turikatuku III Gumada reminded Probuild Manager that Lot 1 DP 817709, 2 Morton Street Parramatta Gondwana Land not excluding surrounding associated rare historical sites of significance being Rangihou and Baludarri Lands are an ancient Originee Massacre and Sacred Burial Site dating back to 1795 and lands gifted to Maori since 1788 by the Darug Tribe. Sanctioned by the Ancestral Originee Grandmother Skin Lore's (Rainbow Serpent Dreaming) Customs and Mortuary Law; **and**
12. Turikatuku III Gumada informed Probuild Manager that **No** development may take place on this site until proper ceremonies have been performed and remissions obtained by Originee and Maori guardians and knowledge keepers of sufficient high ranking sovereign authority. No such ceremonies have been performed and never will. No such remissions have been obtained and never will; **and**
13. Turikatuku III Gumada informed Probuild Manager that we are the Originee and find your term 'Ab-Originee' highly offensive as we are aware of your trickery in your attempt to irradiate us as originators and we will not be removed nor will we Abstain, be ABolished, be ABducted, we will and are ABove your beliefs that you are the owners - the defendants and this court is not the owner or have the ability to make 'rulings' over a people they do not own or posses or a land they do not own or able to make rulings on. Further, it is noted the term 'Aboriginee' also means billable hours, and we affirm that we will be billing for services of novation, do not be confused with this being a form of consent but a penalty fee for the abuses that continue against Originee; **and**
14. Turikatuku III Gumada informed Probuild Manager that Parramatta City Council and Starrylands Sydney Pty Ltd have never produced a True Bill of Sale, Proof of Ownership or a Land Treaty (not including an unlawful LOT DP document) with the Sovereign Darug Ancient Clan for 2 Morton Street Parramatta NSW 2150 to Assembled Owners of Paremata O Baludarri Rangihou Sovereign Nation & Embassy. Affidavits and Notices of Rebuttal are all un rebutted and accepted; **and**
15. Turikatuku III Gumada informed Probuild Manager that Parramatta City Council (Company with ABN masquerading as a government agent has illegally acquired the land after disenfranchising the Originee's from the land through Massacre, genocide and murder of the Originee's 1788 onwards. Thereafter the land was unlawfully granted, sold and reclassified as 2 Morton Street Parramatta NSW 2150, knowing this land was an area of High Aboriginal Archaeological Sensitivity, to private investors such as Fraser Property Australia Pty Ltd, the most recent investor Starrylands Sydney Pty Ltd. That Starrylands Sydney Pty Ltd commissioned Probuild Building Contractors to commence the development of 770 Apartments and 440 car parks; **and**
16. Building Contractors Probuild **ILLEGAL** actions of trespass and pecuniary fraud for personal gains are unlawfully undertaking an unendorsed development on ancient lands, after **FULL DISCLOSURE** the Notice of International Jurisdiction 8<sup>th</sup> September 2014 was hand delivered; **and**

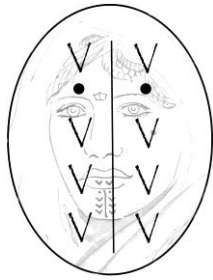
17. Turikatuku III Gumada informed Probuild Manager that Sovereign in Right will assert full powers, sovereign rights, privileges conferred by 'Jingki' Sovereign Queen of Gondwana Land and 1. **Tradition Lores and Customs of the Ancestral Originee Grandmother Skin Lores; 2. Sovereign Nation Treaty; 3. Mortuary Law Authority 2014; 4. Treaty of Versailles 1919 the Covenant of the League of Nations; 5. He Wakaputanga o te Rangatiratanga o Nu Tireni [The Declaration of Independence 1835]; 6. Te Tiriti O Waitangi 1840 [Treaty of Waitangi 1840] 7. Notice of International Jurisdiction 8<sup>th</sup> September 2014 and the** as far and in so far as is possible, in a manner that facilitates and promotes the retention, use, development and control of sacred Massacre and Burial Sites, 2 Morton Street Parramatta; **and**
18. Turikatuku III Gumada informed Probuild Manager that the term “Freehold” is an assumption that the title is free and available to be placed ‘on hold’. However, it is **NOT FREE and NOT ON HOLD and therefore the term FREEHOLD is a form of colour of law and legal-lease WHERE THERE IS NO AUTHORITY NO CONTRACT NO CONSENT for such government office’s and agents to declare this as “Freehold” and is therefore, OFFENSIVE to the true Beneficial Owners and Land Owners ; and**
19. Turikatuku III Gumada informed Probuild Manager that the term **LOT**, when used in reference to the Torrens Titling system is an analogy for the **phrase Location of Title; and**
20. Turikatuku III Gumada informed Probuild Manager that the **Location of Title (LOT)** in a **Deposited Plan (DP)** does not refer to the land as no title can be given lawfully in respect of Title over land upon this island continent ‘Gondwana Land’ due to the fact the Crown has never had nor held absolute title in order to vest title to or in another; **and**
21. Turikatuku III Gumada informed Probuild Manager that at all times absolute title over the lands of Gondwana Land has remained with the Sovereign Tribes of Gondwana Land, in this case Paremata O Baludarri Rangihou Sovereign Nation & Embassy; **and**
22. Turikatuku III Gumada informed Probuild Manager that the Sovereign Tribes of this continent have never KNOWINGLY acquiesced their Title nor dominion over their lands to the Crown in any form nor style; **and**
23. Turikatuku III Gumada informed Probuild Manager that the use of the Act **(63 & 64 VICTORIA, CHAPTER 12) An Act to constitute the Commonwealth of Australia.(9th July 1900)UK (Long Title)** within Australia in respect of and against the freedoms and rights and privileges of Ancient Clan and sovereign members and beneficiaries of Gondwanna Land; places no faith in the integrity of, and refuses to recognise the legality of the purported governments, councils, corporations and its agencies of Australia, nor the “Judicial” system; **and**
24. Turikatuku III Gumada informed Probuild Manager that since at least the 10th of January 1920 signing of the Treaty of Versailles 1919, the Australian Government has been an illegal practice under International Law within the trading name Australia; **and**
25. Turikatuku III Gumada informed Probuild Manager that Australia became a **belligerent Independent Sovereign State on the 28th of June 1919 when the then Prime Minister of Australia (William Hughes) signed the Treaty of Versailles; and**
26. Turikatuku III Gumada informed Probuild Manager that this **FACT** was **FURTHER** evidenced in October 1919, when this fact was recorded in the Hansard of the Parliament of the Commonwealth of Australia; **and**

27. Turikatuku III Gumada informed Probuild Manager that this **FACT** was **FURTHER** ratified on the 10th of January 1920 when Mr. Hughes and the Australian Deputy Prime Minister (Sir Joseph Cook) signed the League of Nations Covenant, making the Commonwealth of Australia a foundation Member; **and**
28. Turikatuku III Gumada informed Probuild Manager that this **FACT** was **FURTHER** ratified in June 1945, when Australia became a foundation member of the United Nations by signing the United Nations Charter; **and**
29. Turikatuku III Gumada informed Probuild Manager that their laws came on a ship. That they are *'Johnny come lately laws'*, foreign to Gondwana Land. No Response; **and**
30. Probuild Construction Manager admitted that he understood that children are buried right across the land of Rangihou and Baludarri Lands, including 2 Morton Street Parramatta. He was sensitive to the children, but he is under contract to complete the development; **and**
31. Turikatuku III Gumada informed Probuild Manager that they will be Invoiced accordingly as per the schedule of fees in the International Jurisdiction 8<sup>th</sup> September; **and**
32. Turikatuku III Gumada asked "has god not given you enough, that you have to build 770 Apartments on top of our children?" No Response; **and**
33. Turikatuku III Gumada stated that they must "**cease and desist**" immediately. There is no other option.
34. Turikatuku III Gumada informed Probuild Manager that lawful action will be undertaken to stop the development immediately.

#### ***COURT FILING OF OUTCOME***

1. The outcome filed by Jury vote was that an unlawful desecration, disruption, disrespect and a direct violation has been committed on the Massacre and Sacred Burial Site regardless of the information presented with FULL DISCLOSURE face to face and in writing by Jingki Sovereign Queen of Gondwana Land, Turikatuku III Gumada, Sovereign Queen of the "Nation", Japanangka, Originee Ancient Clan Elder and Hoori Harihona Paerata Tribal Elder of Aotearoa and Justice of the Peace.
2. Government Agent Parramatta City Council (Company with ABN masquerading as a government agent) has illegally acquired the land after disenfranchising the Originee's from the land through Massacre, genocide and murder of the Originee's 1788 onwards. Thereafter the land was unlawfully granted, sold and reclassified as 2 Morton Street Parramatta NSW 2150, knowing this land was an area of High Aboriginal Archaeological Sensitivity, to private investors, the most recent investor Defendant. That Defendant commissioned Probuild Building Contractors to commence the development of 770 Apartments and 440 car parks.
3. Parramatta City Council and Starrylands Sydney Pty Ltd have never produced a True Bill of Sale, Proof of Ownership or a Land Treaty (not including an unlawful LOT DP document) with the Sovereign Darug Ancient Clan for 2 Morton Street Parramatta NSW 2150 to Assembled Owners of Paremata O Baludarri Rangihou Sovereign Nation & Embassy. Affidavits and Notices of Rebuttal are all un rebutted and accepted; **and**

4. A serious crime is being committed by **Probuild**: Trespass, Desecration of Sacred Land, Desecration of Ancestral Remains, Human rights crimes against humanity, unlawful occupation of ancient clan lands, interference of a sacred Burial Sites, and a blatant disrespect of Jurisprudence under Gods Lore/Law, Common and International Law, Ancestral Originee Grandmother Skin Lores, Mortuary Law.
5. A serious crime is being committed by **Starrylands Sydney Pty Ltd**: Trespass, Desecration of Sacred Land, Desecration of Ancestral Remains, Human rights crimes against humanity, unlawful occupation of ancient clan lands, interference of a sacred Burial Sites, and a blatant disrespect of Jurisprudence under Gods Lore/Law, Common and International Law, Ancestral Originee Grandmother Skin Lores, Mortuary Law.
6. A serious crime has been committed by **Parramatta City Council**. Treachery, Human rights crimes against humanity, economic deprivation, operating a slavery system, trespass, illegally and unlawfully seizing property, selling property, forcible possession, theft, debt bondage, blackmail, extortion, political persecution, interference of tribal sacred lands, and handing out and accepting bribes in the form of grants from developers to indigenous community signatories in order to sell tribal lands and approve developments, unlawful rates and a blatant disrespect of Jurisprudence under Gods Lore/Law, Common and International Law, Ancestral Originee Grandmother Skin Lores, Mortuary Law, Originee and Maori (Kawa, Tikanga, Customary) Lore/Law.
7. A serious crime has been committed by **The Hon Mike Baird MP NSW**: Treachery, Human rights crimes against humanity, economic deprivation, operating a slavery system, illegally being a party to unlawfully seizing property, selling property, illegally being a party to signing off on illegal developments, debt bondage, blackmail, extortion, political persecution, interference of tribal sacred lands, and handing out and accepting bribes in the form of grants from developers to indigenous community signatories in order to sell tribal lands and approve developments, and a blatant disrespect of Jurisprudence under Gods Lore/Law, Common and International Law, Ancestral Originee Grandmother Skin Lores, Mortuary Law, Originee and Maori (Kawa, Tikanga, Customary) Lore/Law.
8. A serious crime has been committed by **The Hon George Brandis Minister for the Arts**: Treachery, Human rights crimes against humanity, economic deprivation, operating a slavery system, illegally being a party to signing off on illegal developments in order to kill culture, debt bondage, blackmail, extortion, political persecution, interference of tribal sacred lands, and handing out and accepting bribes in the form of grants from developers to indigenous community signatories in order to sell tribal lands and approve developments, and a blatant disrespect of Jurisprudence under Gods Lore/Law, Common and International Law, Ancestral Originee Grandmother Skin Lores, Mortuary Law, Originee and Maori (Kawa, Tikanga, Customary) Lore/Law.
9. Notice of Cease and Desist be sent immediately
10. Starryland Sydney Pty Ltd to be invoiced according to Schedule of Fees
11. Probuild to be invoiced according to Schedule of Fees
12. As such we seek to submit a Writ of Enforcement [see attached]



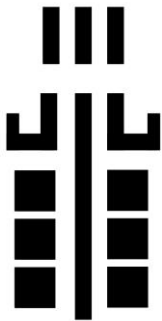

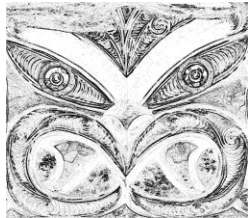
